## **Insurance Contract**

I, the undersigned ("Applicant"), in consideration for the approval of a Proposal by the Village of Buchanan, do hereby agree as follows:

- 1. Applicant shall comply with the requirements of the Village Code of the Village of Buchanan, and any conditions established by the Village Board of the Village of Buchanan, insofar as the Applicant's performance of the permitted work/operations.
- 2. Applicant has secured insurance coverage that is now in force and will remain in force throughout the duration of the permitted work which satisfies the following minimum requirements:
  - (a) Provides commercial general liability coverage of at least \$1,000,000.00; per claim/occurrence and \$2,000,000.00 aggregate.
  - (b) Provides Worker's Compensation coverage of at least equal to the NY State statutory requirements [if applicable]
  - (c) Covers all hazards likely to arise in connection with the permitted work;
  - (d) Includes a waiver of subrogation in favor of the Village of Buchanan; and agents, assigns, officers, employees, volunteers and representatives
  - (e) Provides additional insured status to the Village of Buchanan and agents, assigns, officers, employees, volunteers and representatives until such time as the permitted work is completed; and
  - (f) Provides coverage to the Village of Buchanan that is primary and non-contributory.
  - 3. Applicant shall indemnify and hold harmless the Village of Buchanan and all of its officers and employees, assigns, volunteers, representatives from all loss, damage, claim or expense, including the defense, without limitation, of any litigation involving injury to any person or property, arising out of the performance of the permitted work.
