On August 29, 2019, four (4) bids for the referenced project were received and publicly read aloud at Village Hall. The project was legally advertised in the Journal News.

The work consists of asphalt milling and paving. Other related work includes adjusting drainage structures, adjusting utility frames and covers, curbs, preparing, restoring and cleaning the project area all in accordance with the plans and specifications as directed by the Engineer. The attached bid analysis provides comparison of all line item costs as submitted by the bidders.
