WHEREAS, the Board of Trustees of the Village of Buchanan, after due deliberation, finds it in the best interest of the Village of Buchanan to adopt said Local Law;

NOW BE IT THEREFORE RESOLVED that the Board of Trustees of the Village of Buchanan hereby adopts said Local Law No. 4-2012 amending Chapter 78 entitled Electrical Inspections to the Code of the Village of Buchanan, a copy of which is attached hereto and made a part of this resolution; and

BE IT FURTHER RESOLVED that the Village Clerk be and hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Village of Buchanan, and to give due notice of the adoption of said local law to the Secretary of State of the State of New York.

LOCAL LAW INTRODUCTORY NO. 4 OF THE YEAR 2012**

**A LOCAL LAW AMENDING CHAPTER 78 ENTITLED ELECTRICAL
INSPECTIONS TO THE CODE OF THE VILLAGE OF BUCHANAN**

Section One: The following sections of the Village Code are amended to read as follows:

§ 78-1(a) shall be added to the Code of the Village of Buchanan and shall read as follows:

Permits Required:

The Building Inspector shall, as soon as practical, after the effective date of this chapter, require that a permit be attained by any electrical contractor performing electrical work within the Village of Buchanan. Said permit shall identify the property at which the work will be performed as well as the nature and substance of the work, identify the contractor and his license number and provide a process for the verification that the contractors liability insurance is in full force and effect.

§78-1(b) shall be added to the Code of the Village of Buchanan and shall read as follows:

Fees:

Any fee to be obtained upon the issuance of a permit herein shall be set from time to time by Resolution of the Board of Trustees.

Section Two: This local law shall take effect immediately upon filing with the Secretary of State of the State of New York.
