- 6.Consultant agrees to indemnify and hold harmless the Village of Buchanan for any and all acts of negligence, errors and omissions, claims, judgments and any intentional act that results in a claim and/or demand for damages and/or cost.

7. This Agreement shall be governed by the laws of the State of New York.

- 8.Should any provision of this Agreement be declared ineffective, or void by a court of competent jurisdiction, the remainder of the Agreement shall remain in full force and effect.
- 9. Modifications or amendments to the Agreement must be in writing by both parties.
