A LOCAL LAW AMENDING CHAPTER 211 ENTITLED ZONING TO THE CODE OF THE VILLAGE OF BUCHANAN

Section One: Section 211-5B entitled "Definitions; word usage" shall be amended to read as follows:

PARKING SPACE

A horizontal area used for the parking of a motor vehicle, consisting of a minimum depth of $\frac{20}{18}$ feet and a minimum width of $\frac{10}{8.5}$ feet.

<u>Section Two:</u> This local law shall take effect immediately upon filing with the Secretary of State of the State of New York.


