WHEREAS, the Village Board of Trustees has previously authorized the advertising for proposals to repair roadways throughout the Village; and

WHEREAS, said request for proposals was properly advertised and bids were received and publicly read aloud on June 19, 2024 at 2:00P.M. and

WHEREAS, the following bids were received for repair of roadways and road structures throughout the Village of Buchanan as outlined in plans dated May 31, 2024 and specifications dated June 2024 prepared by James J. Hahn Engineering P.C.:

WHEREAS, Consorti Bros. Paving & Sealcoating, Inc.'s bid is significantly less than all other bidders as shown in the bid tabulation in the correspondence by James J. Hahn Engineering P.C. dated July 18, 2024.

WHEREAS, Consorti Bros. Paving & Sealcoating, Inc. has requested a change order to remove and dispose of road millings offsite.

WHEREAS, Intercounty Paving Co., Inc.'s bid was submitted on time, is consistent with all other bidders, and has not requested a change order to remove and dispose of road millings from the project.

WHEREAS, said bids have been reviewed by the Village Engineer, and the Village Engineer has determined the lowest responsible bidder and received the low bidder's work references;

NOW THEREFORE BE IT RESOLVED, Consorti Bros. Paving & Sealcoating, Inc.'s bid is rejected based on irregularities in the bid which has required one (1) change order and could lead to other change orders.

FURTHER BE IT RESOLVED, that Intercounty Paving Co. Inc., of Carmel NY is awarded the bid subject to the review and approval of the Contract, and the associated Bonds and Insurance, by the Village Engineer and Village Attorney.
